## 2018 TEXAS OIL & NATURAL GAS VITAL STATISTICS

Dear Representative Hernandez,

The Texas Oil & Gas Association (TXOGA) appreciates the role you have in maintaining the State's economic strength. Our industry remains a major force in Texas' prosperity and provides significant funding for government statewide. **In fiscal year 2018, we paid over \$14 billion in state and local taxes and state royalties – that's the equivalent of \$38 million each day. Additionally, the Texas oil and natural gas industry is providing some of the best-paying jobs in Texas, protecting the environment and securing our status as the nation's leader in oil and natural gas production, pipeline miles and refining capacity. **Economists estimate oil and natural gas represents 29% of Texas' Gross State Product.**
