### 2022 TEXAS OIL & NATURAL GAS VITAL STATISTICS

Dear Representative Longoria,

The Texas Oil & Gas Association (TXOGA) appreciates the role you have in maintaining the state's economic strength. Our industry remains a major force in Texas' prosperity and provides significant funding for government statewide.

On the economic front, Fiscal Year 2022 was a record-breaking blockbuster year for tax revenue from the oil and natural gas industry – money that will go to work for the people of Texas. The Texas oil and natural gas industry paid \$24.7 billion in state and local taxes and state royalties – the highest total in history. This revenue from oil and natural gas production, pipelines, refineries and liquified natural gas (LNG) facilities translates to roughly \$67 million a day. And since 2007, industry has paid over \$203 billion. These revenues go towards funding our teachers, public schools and universities, building and repairing roads and other infrastructure, and supporting first responders and other essential services. Additionally, the Texas oil and natural gas industry is providing some of the best-paying jobs in Texas, fortifying our energy security and leading the way in innovation and investment that is advancing environmental progress.

# VITAL STATISTICS

Jobs and payroll data from Texas Workforce Commission are county-based, and thus, the data includes considerable overlapping (for example, all legislative districts having any territory in Harris County are shown including all of Harris County's employment and payroll).
- 2. O&G properties, for this table, include mineral-producing properties, pipelines, and natural gas utilities. They exclude other properties such as refineries and petrochemicals.
- 3. SOURCE: Texas Railroad Commission: Fiscal 2022 production data and number of producing wells.
- 4. Value of production is calculated as Fiscal 2022 production data times the average price for the year.
