## 2018 TEXAS OIL & NATURAL GAS VITAL STATISTICS

Dear Representative Neave,

The Texas Oil & Gas Association (TXOGA) appreciates the role you have in maintaining the State's economic strength. Our industry remains a major force in Texas' prosperity and provides significant funding for government statewide. **In fiscal year 2018, we paid over \$14 billion in state and local taxes and state royalties – that's the equivalent of \$38 million each day.
